March is the Final Month of CalFresh Emergency Allotments

CalFresh Emergency Allotments are ending because the Consolidated Appropriations Act of 2023 ends the issuance of CalFresh Emergency Allotments to households in response to the COVID-19 pandemic.

CalFresh Emergency Allotments were temporary increases to regular CalFresh benefit amounts. This means that since March 2020, households received an increase of at least \$95 in CalFresh benefits per month.

March 2023 is the last month CalFresh Emergency Allotment will issue.

What happens next if you get CalFresh? You will get less CalFresh beginning April 2023. While the regular CalFresh benefit you are eligible for is not changing, you will no longer get the additional CalFresh benefit you have been getting due to the Emergency Allotments ending. The regular CalFresh benefit you get is the CalFresh amount put onto your EBT card between the 1st and 10th of each month. Your regular benefit amount is based on your circumstances, including your household size, income, and deductions. As this is a required change, there are no hearing rights related to the loss of Emergency Allotment benefits. No further action is required.

Los beneficios de emergencia de CalFresh están parrando porque la Ley de asignaciones consolidadas de 2023 finalizo la emisión de beneficios de emergencia de CalFresh a los hogares debido a la pandemia de COVID-19.

Los beneficios de emergencia de CalFresh fueron aumentos temporales aparte de las cantidades regulares. Esto significa que, desde marzo de 2020, los hogares recibieron un aumento de al menos \$95 en beneficios de CalFresh por mes.

Marzo del 2023 es el último mes que se emitirá los beneficios de emergencia de CalFresh.

¿Qué sucede después si recibe CalFresh? Recibirá menos CalFresh a partir de abril de 2023? El beneficio regular de CalFresh que es elegible no cambiará, pero no obtendrá el beneficio adicional de CalFresh que ha estado recibiendo. El beneficio regular de CalFresh que recibe es la cantidad de CalFresh que se deposita en su tarjeta EBT entre el 1 y el 10 de cada mes. El monto de su beneficio regular se basa en sus circunstancias, incluido el tamaño de su hogar, los ingresos y las deducciones. Este cambio es obligatorio, y no existen derechos de audiencia relacionados con la pérdida de los beneficios de emergencia. No se requiere ninguna acción adicional.
