AGREEMENT ASSUMING RISK OR DAMAGE

REQUIREMENTS FOR PARTICIPATING IN CITIZEN RIDE-ALONG PROGRAM

- 1) Applicant must be 18 years of age unless they are a Lake County Sheriff's Office Explorer.
2) Citizens who participate shall be neatly dressed. Shorts, faded or patched pants, tee shirts, sandals, halter tops or similar casual attire will not be permitted.
3) All participants must read the "Statement of Inherent Risk" and sign "Waiver of Claims and Acceptance of Risks" prior to riding.
4) Participants shall follow all instructions of the Deputy to who they have been assigned.
5) Participants shall keep confidential names and/or other information which, if made public, could be detrimental to public safety or which may jeopardize the community standing of any citizen.
6) Participants shall not become involved, nor be permitted to become involved, in the official duties of the Department, unless specifically requested by the deputy to do so.
7) If a deputy is dispatched to a hazardous call, the participant acknowledges that he/she may be asked to exit the vehicle and wait to be picked up after the danger is over.
8) At no time will a citizen be permitted to use any recording device (cell phone, recorder, GoPro, etc.) while participating on a ride-along.
9) Failure to follow any of the above requirements will result in the termination of the ride-along and all future ride-along requests will be denied.

STATEMENT OF INHERENT RISK

The Lake County Sheriff's Office encourages community involvement through programs which serve to educate citizens about the Lake County Sheriff's Office and the law enforcement profession. These risks may arise from, but are not limited to, civil disturbances, explosions, shootings, rain, wind, fire, gas, vehicle collisions, assaults and/or batteries.

WAIVER OF CLAIMS AND ACCEPTANCE OF RISK

The undersigned, having made a voluntary request to accompany and ride as a guest with a member of the lake County Sheriff's Office, acknowledges reading and understanding the aforementioned "Statement of Inherent Risks" and by hereby freely and voluntarily assumes all of said inherent risks, whether or not they are listen therein. Now, therefore, be it resolved that the undersigned hereby agrees to indemnify and hold harmless the Sheriff of Lake County, the County of Lake, any member of the Lake County Sheriff's Office from any and all claims, demands, actions, liabilities or loss which may arise from or be incurred as the result of injury or damages to my person or property arising out of the undersigned's actions or riding with a member of the Lake County Sheriff's Office.
